1	Nomination Papers shall be presented:	On 24 th , 26 th and 28 th December, 2020 (between 11.00 am to 3.00 pm) Nomination papers shall be filed at designated places and before the Officers appointed by the Returning Officer for the purpose .
2	The Nomination papers shall be scrutinized:	On 29 th December,2020 (from 10.00 am onwards)
3.	A candidate may withdraw his candidature:	On 31 st December,2020 (between 10.00 am to 3.00 pm)
4.	The list of contesting candidates showing the name of symbol allotted to them shall be prepared and affixed:	On 31 st December, 2020 immediately after the time of withdrawal is over.
5.	The list of polling stations shall be pasted:	On or before 24 th December, 2020
6.	The Poll, if necessary shall be held from 8.00 am to 4.00 pm	On 10 th January, 2021
7.	The counting, in the event of poll shall be undertaken:	The counting of votes shall be undertaken immediately after the close of poll at the Municipal Headquarters
8.	The Result of election shall be declared:	The result shall be declared immediately after counting is over.
8.	The process of election shall be completed by:	12 th January, 2021
