NOTIFICATION

In exercise of the powers vested in it under Article 243-ZA of the Constitution of India, Section 281 of the Himachal Pradesh Municipal Act, 1994 read with Rule 35 of the H P Municipal Election Rules, 2015, the State Election Commission Himachal Pradesh hereby notifies the Election Programme for the conduct of general elections to six Nagar Panchayats viz. Chirgaon and Nerwa district Shimla, Ani and Nirmand district Kullu, Kandaghat district Solan and Amb district Una as under :-

1	Nomination papers shall be presented;	On 22 nd , 23 rd & 24 th March, 2021 (between 11.00 am to 3.00 pm). Nomination papers shall be filed at designated places and before the Officers appointed by the Returning Officer for the purpose.
2	The nomination papers shall be scrutinized;	On 25 th March, 2021 (From 10.00 am onwards)
3	A candidate may withdraw his candidature;	On 27 th March, 2021 (Between 10.00 am to 3.00 p.m.)
4	The list of contesting candidates showing the name of symbols allotted to them immediately after the time of withdrawal is over shall be prepared and affixed;	On 27 th March, 2021 immediately after the time of withdrawal is over.
5	The list of Polling stations shall be pasted ;	On or before 22 nd March, 2021.
6	The Poll, if necessary, shall be held from 8.00 AM to 4.00 PM	On 7 th April, 2021
7	Counting of votes, in the event of poll, shall be done	The Counting of votes shall be taken up immediately after the close of the poll at the Municipal Headquarters


