

## **Scheme of Parking in the H.P.**

Increase in Urban population, household income and commercial activities has increased the demand for transport. In sufficient and poor quality public transport system in Urban areas has led to passengers switching to personalized modes and intermediate public transport resulting in the increase in the number of vehicles on road. Himachal Pradesh being a hilly state and its urban population is 688522, the decennial growth rate is 32.98% meaning thereby that more and more people are attracted towards the cities/town causing congestion on roads, markets and other public places. With the increase in number of vehicles on road, it leads to road congestion and traffic jams necessitating the construction of parking in the towns.

There are 54 municipalities in the State, (2 Municipal Corporations, 31 Municipal Councils and 21 Nagar Panchayats). In the year 2015-16 the Govt. has allocated a budget provision of Rs. 15.00 crore for the construction of parking under matching grant of 50:50 schemes, which stand released to the 9 ULBs as per **Annexure "A"** attached.

In the year 2016-17, there was a budget provision of Rs. 10.00 crore for which all the ULB's have been asked vide this office letter dated 7<sup>th</sup> May 2016 to send the proposal for the construction of Parkings in their respective ULBs. After receiving the proposals the necessary funds released to the ULB's. The detail of funds released is attached at **Annexure "B"**.

In the current financial year there is a budget provision of Rs. 10.00 crore, funds amounting to Rs. 7.80 has been released to 16 ULBs on dated 25.09.2017. The detail of funds released is attached at **Annexure "C"**.
