In exercise of the powers conferred by section 31 of the Himachal Pradesh Municipal Corporation Act, 1994 (Act No.13 of 1994), the Governor, Himachal Pradesh, in consultation with the State Election Commission, is pleased to make the following rules further to amend the Himachal Pradesh Municipal Corporation (Election) Rules, 2012, notified vide Notification No.UD-A(3)-7/2011 dated 23.3.2012 and published in the Rajpatra, Himachal Pradesh on 24.3.2012, namely:-

Short title.	1	These rules may be called the Himachal Pradesh Municipal Corporation (Election) Amendment Rules, 2017.
