## Jawaharlal Nehru National Urban Renewal Mission (JNNURM):-

Shimla has been covered under Jawaharlal Nehru Urban Renewal Mission (JNNURM), which was launched by the Hon'ble Prime Minister of India on 3<sup>rd</sup> December, 2005 for developing basic infrastructure in 63 cities of India. JNNURM is aiming at economically self-reliant, efficient, equitable and responsive cities with very high transparency and service levels. The mission aims at fast-track development of urban infrastructure and service delivery mechanisms, community participation, basic services to the poor and accountability of ULB's towards the citizens.

The Mission comprises two Sub- Missions:-

- 1. Urban Infrastructure and Governance (UIG) (Funding Pattern 80:10:10): Under this sub mission Urban infrastructure/ service delivery Mechanism, community participation and accountability of local bodies has been focused.
- 2. Basic services to the Urban Poor (BSUP) (funding Pattern 80:20): This sub mission includes integrated development of slums through projects for providing shelter, basic services and other related civic amenities to the urban poor of the Mission cities. A maximum of 12.5% (10% in case of SC/ST/BC/OBC/PH and other weaker sections) of the Cost or Rs.30,000/- per Dwelling Unit is to be contributed by beneficiary.

## **Nodal Agency:-**

As per the Government notification No.UD-B(12)-3/2006 dated 21-04-2006, H.P. Housing & Urban Development Authority (HIMUDA) was appointed as Nodal Agency to assist the State Level Steering Committee. But now as per Notification issued on 30.07.2013, Directorate of Urban Development has been declared as SLNA.
